Midshore I / Talbot Transfer Scale Hours of Operations

Monday-Friday 8:00 a.m. to 12:00 p.m.

There are no Saturday or Sunday hours for the Talbot Transfer Scale House.

Tipping Fees

Residential & Commercial Waste - \$85.50 per ton w/a \$10 minimum fee (up to 220 lbs.)

Mattresses - \$30/each surcharge

Brush & Yard Waste - \$60.50 per ton w/a \$10 minimum fee (up to 320 lbs.)

Maximum width 24-inch diameter / 6-foot length or less

Items longer and/or larger are Lead Clearing Debris and will be redirected to the Midshore II Regional Solid Waste Facility in Ridgely, MD, and charged full price.

Tire Surcharges

Note: Tire per surcharge is in addition to the standard tip fee (charge for weight), which will be \$85.50/ton effective on 07/01/2026.

There is a limit of 5 tires per year, per resident without a Scrap Tire Haulers License.

If you need a Tire Haulers License, please contact the MDE Scrap Tire Division at (410) 537-3315. Most temporary scrap tire licenses are sent via fax or email. If needed, you may have the license faxed directly to the MSI/Talbot Transfer Office at (410) 820-8385 or Sarah Schunick-Baney at sbaney@menv.com.

Passenger Tires (tire size < 15)

\$4.00 per tire without a rim and clean + Weight Charge / \$85.50 per ton

\$8.00 per tire w/rim and/or dirty + Weight Charge / \$85.50 per ton

Light Truck Tires (tire size > 16)

\$5.50 per tire without a rim and clean + Weight Charge / \$85.50 per ton

\$11.00 per tire w/rim and/or dirty + Weight Charge / \$85.50 per ton

Heavy Truck Tires (tire sizes 9.0 and up)

\$16.50 per tire without a rim and clean + Weight Charge / \$85.50 per ton

\$33.00 per tire w/rim and/or dirty + Weight Charge / \$85.50 per ton

Off the Road (OTR) Tire

\$400.00 per ton + Weight Charge \$85.50 per ton = \$485.50 per ton

OR

\$125.00 per tire + Weight Charge \$85.50 per ton

(When commingled with other non-OTR tires or waste.)

ATTENTION: Asbestos, Ashes, Blown-in Insulation or Small Dusty Particles, Clean Soil, Clean Rubble (brick, block, asphalt, stone, etc.), Sludge, Liquids or Hazardous Materials (*Hazardous Materials have never been accepted and will not be accepted at either facility*) ARE NOT accepted at Talbot Transfer (this facility).

Those items will be sent to the Midshore II Regional Solid Waste Facility located at 12236 River Road, Ridgely, MD, 21660, (410) 634-9304. The hours for those facilities scales are:

Monday-Friday – 7:00 a.m. to 3:15 p.m. (last load accepted)

Saturday – 7:00 a.m. to 12:15 p.m. (last load accepted)

The landfill in Ridgely is not open on Sunday.

Midshore I / Talbot Homeowners Drop Off

Hours of Operation

Monday-Friday – 8:00 a.m. to 12:00 p.m.

Saturday – 8:00 a.m. to 4:00 p.m.

There are no Sunday hours for the Talbot Homeowners Drop Off.

Trailers of any kind are PROHIBITED from entering the Homeowners Drop Off Area.

As of Monday, August 1, 2011, a Punch Card System went into effect for the MSI/Talbot Homeowners Drop Off site. You may buy your Punch Card on site at the Scalehouse Monday-Friday – 8:00 a.m. to 12:00 p.m.

\$5 – One-Time Fee = A 1-time trip of up to 7 bags or less (trash/brush or a combination)

\$10 – Punch Card = 5 trips of/up to 7 bags or less (trash/brush or a combination) per punch

\$20 – Punch Card = 10 trips of/up to 7 bags or less (trash/brush or a combination) per punch

The guidelines for the use of the Talbot County Homeowners Drop Off are as follows:

7 bags* of trash (normal household trash that comes out of your kitchen or bathroom) or the equivalent of 7 bags** of brush*** are accepted. Please empty your brush into the Brush Can. DO NOT throw any plastic bags into the Brush Can. Please dispose of the plastic bag(s) in the Trash Compactor. A combination of 7 bags of trash and/or brush is accepted per day.

*A bag size limit of 32/33 gallons per bag is in effect. If using a 55-gallon bag, only 4 per day are permitted.

**A small pickup load = full bed or truck under or at the top rim of bed or brush.

A large pickup load = half of the bed (front, back, or height) at or under the tip rim of the bed of brush.

***Brush = Grass cuttings with very little dirt, dead plants, twigs, branches, leaves, or shrubs (all must be organic/natural).

The Recycling Area (behind the HODO Area) is ALWAYS FREE OF CHARGE.

The Electronics Recycling Container (blue top green bottom sea container across from the Sscalehouse) is for Computers, computer Components (towers, lcd/slim monitors (not CRTs), keyboards, mice, and speakers), VCRs, DVD Players, Copier, Fax Machines, Scanners, Video Game Machines, iPod & PDAs, Circuit Boards, External Disc Drivers, Modems, Stereo Equipment, Telephones, Cellphones, Cameras, Tablets & eBooks, Small Electronic Appliances, Cables & Wires, Answering Machines, Christmas/Holiday lights, and LCD TVs **ONLY**.
