


Remarks: MES is in the process of converting the Cogen plant from

burning wood chips to natural gas (NG) under separate contracts. The NG service pipeline is expected to be completed in June 2022 and the boilers converted and able to burn NG by February 2023. Under this contract, the A/E shall design, prepare bid ready documents and provide bidding support to convert the ECI Annex and MCE buildings from firing propane to fire NG and to extend a distribution pipeline to deliver NG to the affected buildings. The design scope includes consideration of the mechanical rooms space constraints, the systems these equipment serve, DPSCS request to design a minimum of two options for each equipment replacement, permitting efforts through MDE and Somerset County, and determination of all necessary construction inspections. There are a total of 19 pieces of propane fired

equipment affected; 15 pieces of equipment at the Annex will be replaced and four (4) pieces of equipment at the MCE will either be replaced or converted based on a cost anylsis performed by the A/E. Permitting efforts are expected to include erosion and sediment control and stormwater management. Emissions permitting for construction and operation are handled under a separate contract.

Remarks: MES reviewed all bids to check for bid responsiveness and mathematical errors and found no anomalies. The two lowest bids are closely grouped suggesting the prices are reflective of current market conditions and reliable. Although the bids are higher than the engineer's estimate, they appear consistent with recent pricing trends due to cost of materials, labor, and supply chain issues.

The existing sludge dewatering system consists of a single sludge dewatering belt filter press and associated sludge and polymer feed pumps all of which have been in operation for more than 28 years. Because of wear and tear, the dewatering equipment currently requires frequent repairs to keep it operational. Under the proposed upgrade, the dewatering facility will be refurbished and provided redundancy to ensure reliability of the system for foreseeable future.


